### Ch'utwuj rech K'amow

- We kina chapö, xaq kinköj wiwa' rinu k'amow kinch'awtaj ruk' man kin soltauwach ri k'atowchi'aj ka b'anö.
- Kinwaj kinch'aw ruk' jun abogad nab'e te'ri kinsoluwaq ri k'atowchi'aj kab'anö.
- Man kin yatamod chawech katokik or katsolinik.
- Man kin juch'ta nitajun wuj ri man kin ch'ob'taj

## Know Your Rights:

### What to do in case of an ICE encounter:

- **DO** remain calm
- **DO** remember: You have the right to remain silent.
  - ♦ Anything you say can be used against you
- **You have the right to say**, "I do not wish to speak with you or answer your questions."
- **DO** report the encounter to ICIRR's Family Support Hotline

**SIGN UP &  
TAKE ACTION**



### If you suspect you might be arrested by ICE:

- **You have the right to ask** "Am I under arrest?" and "Am I free to go?"
- **DO** tell them you want to remain silent and want to speak to a lawyer

### What NOT TO DO in case of an ICE encounter:

- **You are NOT required to OPEN THE DOOR TO YOUR HOME** WITHOUT A WARRANT SIGNED BY A JUDGE
- **You are NOT required to SIGN** any document
- **DO NOT LIE.** Don't give explanations, excuses or stories
- **DO NOT RUN**
- **You are NOT required to say anything** except that you wish to remain silent

- I do not consent to your entry or search.
- I will not sign any document I do not understand.
